

INSURANCE REQUIREMENTS

1. You must be State of Florida licensed & Insured.
2. A \$100.00 cash deposit **MUST** be in file for the corresponding unit.
3. We must have a copy of the Occupational License and a copy of the Certificate of Liability/Property Insurance and Workmen's Compensation certifying us as the Certificate holder, additional insurer and Waiver of Subrogation endorsement; The Village of Kings Creek Condominium, with our address 7711 Camino Real, Miami FL-33143. The Worker's Compensation must also include Waiver of Subrogation Endorsement for The Village of Kings Creek.
4. If you are exempt for Workmen's Comp, we need copy of this certificate and the names of the persons exempt. If you submit and Exemption – **ONLY** the person(s) listed on the Exemption(s) will be allowed to perform the work.
5. THE CERTIFICATE OF INSURANCE MUST BE EMAILED OR MAILED DIRECTLY FROM THE INSURANCE COMPANY.
